

DSWD DROMIC Report #1 on the Fire Incident in Brgy. Cambanay, Danao City, Cebu

as of 09 January 2024, 6PM

I. Situation Overview

On 05 December 2023 at around 10:18 PM, a fire incident occurred at Sitio Pangdan, Brgy. Cambanay, Danao City, Cebu. The fire was declared out at around 11PM.

II. Status of Affected Areas and Population

One (1) family or **five (5) persons** are affected in **Brgy. Cambanay, Danao City, Cebu** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **five (5) persons** temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Cambanay, Danao City, Cebu** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱20,717.00** worth of assistance was provided to the affected family; of which, **₱8,717.00** from **DSWD** and **₱12,000.00** from the **Local Government Unit (LGU)** (see Annex D).
