## I. Situation Overview

On 13 December 2023 at around 9:30 AM, a fire incident occurred at Brgy. Dungga, Danao City, Cebu. The fire was declared out at around 10:00 AM.

One (1) house was totally damaged in Brgy. Dungga, Danao City, Cebu (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of ₱10,717.00 worth of assistance was provided to the affected family; of which, ₱8,717.00 from DSWD and ₱2,000.00 from the Local Government Unit (LGU) (see Annex D).
