

DSWD DROMIC Report #1 on the Fire Incident in Brgy. Pantalan, Orani, Bataan

as of 05 January 2024, 6PM

I. Situation Overview

On 27 December 2023 at around 9:30 AM, a fire incident occurred in Brgy. Pantalan, Orani, Bataan.

II. Status of Affected Areas and Population

A total of **13 families** or **47 persons** are affected in **Brgy. Pantalan, Orani, Bataan**. (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

There are **13 families** or **47 persons** temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **13 houses** were damaged; of which, **nine (9)** are **totally damaged** and **four (4)** are **partially damaged** in **Brgy. Pantalan, Orani, Bataan**. (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱130,000.00** worth of assistance was provided by the **Local Government Unit (LGU)** to the affected families (see Annex D).
