I. Situation Overview

On 01 January 2024 at around 10:30 AM, a fire incident occurred in Brgy. Villar, Sibalom, Antique. The fire was declared out at around 11:23 AM.

One (1) family or **five (5) persons** are affected in **Brgy. Villar, Sibalom, Antique** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **five (5) persons** are temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was partially damaged in Brgy. Villar, Sibalom, Antique (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱5,865.78 worth of assistance was provided by DSWD to the affected family (see Annex D).
