

DSWD DROMIC Report #2 on the Armed Conflict in Shariff Saydona Mustapha, Maguindanao del Sur as of 26 January 2024, 6PM

I. Situation Overview

On 11 January 2024 at around 10:30 AM, an armed conflict transpired between the alleged members of the 105th Base Command and the combined force of 106th and 118th Base Command of the Moro Islamic Liberation Front (MILF) at Sitio Patawili, Brgy. Ganta, Shariff Saydona Mustapha, Maguindanao del Sur resulting to displacement of families and individuals.

II. Status of Affected Areas and Population

A total of **1,169 families** or **5,845 persons** are affected in **three (3) barangays** in **Shariff Saydona Mustapha, Maguindanao del Sur** (see Annex A).

III. Status of Displaced Population

a. Inside Evacuation Center

There are **379 families** or **1,895 persons** currently taking temporary shelter at the **Bakat Masjid Evacuation Center** in **Shariff Saydona Mustapha, Maguindanao del Sur** (see Annex B).

b. Outside Evacuation Center

There are **790 families** or **3,950 persons** temporarily staying with their relatives or friends (see Annex C).

c. Total Displaced Population

There are **1,169 families** or **5,845 persons** displaced in **Shariff Saydona Mustapha, Maguindanao del Sur** (see Annex D).

IV. Cost of Humanitarian Assistance Provided

A total of **₱ 754,005.00** worth of assistance from **DSWD** was provided to the affected families. (see Annex E).
