## **DSWD DROMIC Report #2 on the Fire Incident in Brgy. San Miguel, Puerto Princesa City, Palawan** as of 20 January 2024, 6PM

### **I. Situation Overview**

On 17 January 2024 at around 4:45 AM, a fire incident occurred in Brgy. San Miguel, Puerto Princesa City, Palawan. The fire was declared out at around 6:00 AM.

### **II. Status of Affected Areas and Population**

A total of **16 families** or **47 persons** are affected in **Brgy. San Miguel, Puerto Princesa City, Palawan** (see Annex A).

### **III. Status of Displaced Population**

#### **a. Inside Evacuation Center**

There are **nine (9) families** or **24 persons** currently taking temporary at the **Barangay Hall of Brgy. San Miguel, Puerto Princesa City, Palawan** (see Annex B).

#### **b. Outside Evacuation Center**

There are **seven (7) families** or **23 persons** temporarily staying with their relatives or friends (see Annex C).

#### **c. Total Displaced Population**

There are **16 families** or **47 persons** displaced in **Brgy. San Miguel, Puerto Princesa City, Palawan** (see Annex D).

### **IV. Damaged Houses**

A total of **nine (9) houses** were damaged; of which, **six (6)** are **totally damaged** and **three (3)** are **partially damaged** in **Brgy. San Miguel, Puerto Princesa City, Palawan** (see Annex E).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱168,208.00** worth of assistance was provided to the affected families; of which, **₱22,728.00** from **DSWD** and **₱145,480.00** from the **Local Government Unit (LGU)** (see Annex F).
