

DSWD DROMIC Report #4 on the Fire Incident in Brgy. Carreta, Cebu City as of 13 January 2024, 6PM

I. Situation Overview

On 06 January 2024 at around 9:23 PM, a fire incident occurred at Sitio Kalapukan, Brgy. Carreta, Cebu City. The fire was declared out at around 10:48 PM.

II. Status of Affected Areas and Population

A total of **155 families** or **631 persons** are affected in **Brgy. Carreta, Cebu City** (see Annex A).

III. Status of Displaced Population

a. Inside Evacuation Center

There are **90 families** or **534 persons** currently taking temporary shelter at the **Carreta Elementary School** in **Brgy. Carreta, Cebu City** (see Annex B).

b. Outside Evacuation Center

There are **65 families** or **97 persons** temporarily staying with their relatives or friends (see Annex C).

c. Total Displaced Population

There are **155 families** or **631 persons** displaced in **Brgy. Carreta, Cebu City** (see Annex D).

IV. Damaged Houses

A total of **87 houses** were **totally damaged** in **Brgy. Carreta, Cebu City** (see Annex E).

V. Cost of Humanitarian Assistance Provided

A total of **₱3,596,234.75** worth of assistance was provided to the affected families; of which, **₱51,074.75** from **DSWD** and **₱ 3,545,160.00** from the **Local Government Unit (LGU)** (see Annex F).
