



DSWD DROMIC Report on the Fire Incident in Brgy. Agsirab, Lambunao, Iloilo

13 January 2024, 6PM

I. Situation Overview

On 15 November 2023 at around 2:30 AM, a fire incident occurred at Sitio Maisan, Brgy. Agsirab, Lambunao, Iloilo.

II. Status of Affected Areas and Population

One (1) family or three (3) persons were affected in Brgy. Agsirab, Lambunao, Iloilo (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **three (3) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Agsirab, Lambunao, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱14,097.00 worth of assistance was provided to the affected family; of which, ₱8,168.00 from the DSWD and ₱5,929.00 from the Local Government Unit (LGU) (see Annex D).
