I. Situation Overview

On 24 December 2023 at around 11:00 PM, a fire incident occurred in Brgy. Barasan, Igbaras, Iloilo. Based on the report from the Municipal Social Welfare and Development Office (MSWDO), the affected one (1) family or three (3) individuals with one (1) totally damaged were temporarily stayed with their relatives or friends.
