## DSWD DROMIC Report on the Fire Incident in Brgy. Baybay Norte, Miag-ao, Iloilo

19 January 2024, 6PM

### I. Situation Overview

On 04 January 2024 at around 11:00 AM, a fire incident occurred at Brgy. Baybay Norte, Miag-ao, Iloilo.

A total of **two (2) families** or **eight (8) persons** were affected in **Brgy. Baybay Norte, Miag-ao, Iloilo** (see Annex A).

### III. Status of Displaced Population

#### Outside Evacuation Center

A total of **two (2) families** or **eight (8) persons** temporarily stayed with their relatives or friends (see Annex B).

### IV. Damaged Houses

A total of **two (2) houses** were damaged; of which, **one (1)** was **totally damaged** and **one (1)** was **partially damaged** in **Brgy. Baybay Norte, Miag-ao, Iloilo** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱11,731.56** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
