I. Situation Overview

On 20 June 2023 at around 2:30 PM, a fire incident occurred at Brgy. Boloc, Tubungan, Iloilo.

One (1) family or four (4) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Boloc, Tubungan, Iloilo (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱3,927.00 worth of assistance was provided to the affected families; of which, ₱3,627.00 from DSWD and ₱300.00 from the Local Government Unit (LGU) (see Annex D).
