
DSWD DROMIC Report on the Fire Incident in Brgy. Cayan Oeste, Lambunao, Iloilo

11 January 2024, 6AM

I. Situation Overview

On 03 December 2023 at around 11:30 PM, a fire incident occurred at Brgy. Cayan Oeste, Lambunao, Iloilo. The Bureau of Fire Protection (BFP) responded to the scene and declared fire out the same day.

In response, the DSWD through its Field Office in Region VI together with the LGU of Lambunao, Iloilo promptly provide intervention to support the immediate needs of the affected family.

II. Status of Affected Areas and Population

A total of **1 family** or **six (6) persons** were affected in **Brgy. Cayan Oeste, Lambunao, Iloilo** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **six (6) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Cayan Oeste, Lambunao, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱13,690.00** worth of assistance was provided to the affected family; of which, **₱8,168.00** from **DSWD** and **₱5,522.00** from the **Local Government Unit (LGU)** (see Annex D).
