
DSWD DROMIC Report on the Fire Incident in Brgy. Manoc-Manoc, Malay, Aklan

11 January 2024, 6AM

I. Situation Overview

On 21 June 2023 at around 9:00 AM, a fire incident occurred at Brgy. Manoc-Manoc, Malay, Aklan. Based on the investigation conducted by the Bureau of Fire Protection (BFP), it was identified that a faulty electrical wiring from a hardware/warehouse was the alleged cause of fire. The fire was declared out at around 11:00 AM.

In response, the DSWD through its Field Office in Region VI, promptly provide intervention to support the immediate needs of the affected individuals.
