
DSWD DROMIC Report on the Fire Incident in Brgy. Mayombo, Dagupan City, Pangasinan

26 January 2024, 6PM

I. Situation Overview

On 01 January 2024 at around 12:24 AM, a fire incident occurred in Brgy. Mayombo, Dagupan City, Pangasinan. CSWDO of Dagupan, Pangasinan, in coordination with its Local Government Unit, the Department of Social Welfare and Development through its Field Office in Region 1 provided relief assistance to the affected family.

Moreover, the LGU of Dagupan City, assumes the management of Internally Displaced Persons (IDPs) and commits to continuously provide interventions as necessary hence, the termination of this report.

A total of **₱8,641.00** worth of assistance was provided to the affected family; of which, **₱7,641.00** from **DSWD** and **₱1,000.00** from the **Local Government Unit (LGU)** (see Annex D).
