I. Situation Overview

On 01 January 2024 at around 6PM, a fire incident occurred in Brgy. Oyungan, Miagao, Iloilo. The fire was declared out at around 7PM.

In response, the DSWD through its Field Office in Region VI provided relief assistance to support the immediate needs of the affected family.
