## **DSWD DROMIC Report on the Fire Incident in Brgy. Paitan, Esperanza, Sultan Kudarat**

26 January 2024, 6PM

### **I. Situation Overview**

On 18 January 2024 at around 11:30 PM, a fire incident occurred at Brgy. Paitan, Esperanza, Sultan Kudarat.

In response, the DSWD through its Field Office in Region XII, together with the Municipality of Esperanza Social Welfare and Development Office, promptly provided relief assistance to support the immediate needs of affected families and individuals.

Moreover, the LGU of Esperanza, Sultan Kudarat assumes the management of Internally Displaced Persons (IDPs) and commits to continuously provide interventions as necessary hence, the termination of this report.

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱57,123.00** worth of assistance was provided to the affected families from the **DSWD** (see Annex D).
