



DSWD DROMIC Report on the Fire Incident in Brgy. Pantay Tamurong, Caoayan, Ilocos Sur

21 January 2024, 6PM

I. Situation Overview

On 10 January 2024 at around 2:00 PM, a fire incident occurred in Brgy. Pantay Tamurong, Caoayan, Ilocos Sur. The fire was declared out at around 6:11 AM.

One (1) family or six (6) persons were affected in Brgy. Pantay Tamurong, Caoayan, Ilocos Sur (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **six (6) persons** temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Pantay Tamurong, Caoayan, Ilocos Sur** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱12,794.00 worth of assistance was provided to the affected family; of which, ₱10,794.00 from DSWD and ₱2,000.00 from the Local Government Unit (LGU) (see Annex D).
