



DSWD DROMIC Report on the Fire Incident in Brgy. San Isidro, Jaro, Iloilo City

25 January 2024, 6PM

I. Situation Overview

On 03 January 2024 at around 6:45 AM, a fire incident occurred in Brgy. San Isidro, Jaro, Iloilo City. As reported by the Bureau of Fire Protection (BFP), the cause of the fire was due to a mosquito coil that was left unattended. The fire was declared out at around 7:37 AM.

In response to the incident, the DSWD through its Field Office in Region VI together with the LGU of Jaro, Iloilo City, provided intervention to support the immediate needs of affected families and individuals by means of relief assistance.

II. Status of Affected Areas and Population

A total of **two (2) families** or **10 persons** were affected **Brgy. San Isidro, Jaro, Iloilo City** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **two (2) families** or **10 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of two (2) houses were damaged; of which, one (1) is totally damaged and one (1) is partially damaged in Brgy. San Isidro, Jaro, Iloilo City (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱22,098.90** worth of assistance was provided to the affected families; of which, **₱13,124.00** from **DSWD** and **₱8,974.90** from the **Local Government Unit (LGU)** (see Annex D).


