





# DSWD DROMIC Report on the Fire Incident in Brgy. Taculing, Bacolod City, Negros Occidental

24 January 2024, 6PM

## I. Situation Overview

On 20 December 2023 at around 12:30 PM, a fire incident occurred in Barangay Taculing, Bacolod City, Negros Occidental. According to the Bureau of Fire Protection (BFP), the cause of the fire was due to a faulty electrical wire. The fire was declared out at around 1:35 PM.

To date, the displaced family have transferred to their newly built house in the same barangay. Moreover, the DSWD through its Field Office in Region VI provided relief assistance to support the immediate needs of the affected family.
