





# DSWD DROMIC Report on the Fire Incident in Brgy. Talaptap, La Castellana, Negros Occidental

26 January 2024, 6PM

#### I. Situation Overview

On 19 January 2024 at around 11:30 AM, a fire incident occurred at Brgy. Talaptap, La Castellana, Negros Occidental. The fire was declared out at around 12:45 PM.

In response, the DSWD through its Field Office in Region VI together with the LGU of La Castellana, Negros Occidental, provided relief assistance to support the immediate needs of affected family.

One (1) houses was totally damaged in Brgy. Talaptap, La Catellana, Negros Occidental (see Annex C).

#### V. Cost of Humanitarian Assistance Provided

A total of **₱10,037.00.00** worth of assistance was provided to the affected families; of which, **₱5,307.00** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
