



DSWD DROMIC Report on the Fire Incident in Brgy. Taytay, Igbaras, Iloilo

23 January 2024, 6PM

I. Situation Overview

On 23 December 2023 at around 12:20 PM, a fire incident occurred in Brgy. Taytay, Igbaras, Iloilo. According to the report of the Municipal Social Welfare and Development Office (MSWDO), the affected family and individuals were temporarily stayed in a makeshift house.

One (1) family or seven (7) persons were affected in Brgy. Taytay, Igbaras, Iloilo (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **seven (7) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Taytay, Igbaras, Iloilo (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P8,060.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
