I. Situation Overview

On 23 December 2023 at around 12:20 PM, a fire incident occurred in Brgy. Taytay, Igaras, Iloilo. According to the report of the Municipal Social Welfare and Development Office (MSWDO), the affected family and individuals were temporarily stayed in a makeshift house.
