

# **DSWD DROMIC Terminal Report on the Armed Conflict in Brgy. Nunangan, Datu Anggal Midtimbang, Maguindanao del Sur**

22 January 2025, 6AM

## **I. Situation Overview**

On 24 January 2024 at around 9AM, an armed conflict involving two warring commanders of 104<sup>th</sup> Base Command of the Moro Islamic Liberation Front (MILF) transpired in Brgy. Nunangan, Datu Anggal Midtimbang, Maguindanao del Sur. The incident led to the displacement of families and individuals within the affected community.

In response to the incident, the Department of Social Welfare and Development (DSWD) through its Field Office in Region XII, provided relief assistance to support the immediate needs of the affected populace.

A total of **710 families** or **3,550 persons** were affected in **two (2) barangays** in **Datu Anggal Midtimbang, Maguindanao del Sur** (see Annex A).

A total of **710 families** or **3,550 persons** temporarily stayed with their relatives or friends (see Annex B).

## **IV. Cost of Humanitarian Assistance Provided**
