



DSWD DROMIC Terminal Report on the Fire Incident in Brgy. 262, Tondo, Manila City

24 January 2024, 6PM

I. Situation Overview

On 11 January 2024 at around 3:50 PM, a fire incident occurred at 1314 Mayhaligue St. Corner Masangkay, Brgy. 262, Tondo, Maynila City. The fire was declared out at around 4:28 PM.

A total of **49 families** or **176 persons** were affected in **1314 Mayhaligue St. Corner Masangkay, Brgy. 262, Tondo, Maynila City**. (see Annex A).

A total of 49 families or 176 persons temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

A total of **25 houses** were damaged; of which, **24** are **totally damaged** and **one (1)** are **partially damaged** in **1314 Mayhaligue St. Corner Masangkay, Brgy. 262, Tondo, Maynila City**. (see Annex C).
