I. Situation Overview

On 09 March 2024 at around 7:00 PM, a fire incident occurred in Brgy. Biasong, Loon, Bohol. The fire was declared out at around 8:56 PM.

One (1) family or **three (3) persons** were affected in **Brgy. Biasong, Loon, Bohol** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **three (3) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One house was **totally damaged** in **Brgy. Biasong, Loon, Bohol** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱10,969.80** worth of assistance was provided to the affected family; of which, **₱5,969.80** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
