

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Dungga, Danao City, Cebu

25 January 2025, 6PM

I. Situation Overview

On 13 December 2023 at around 9:30 AM, a fire incident occurred at Brgy. Dungga, Danao City, Cebu. The fire was declared out at around 10:00 AM.

One (1) family or four (4) persons were affected in **Brgy. Dungga, Danao City, Cebu** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

One (1) family or four (4) persons sought temporary shelter in **Brgy. Dungga Chapel** in **Brgy. Dungga, Danao City, Cebu** (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Dungga, Danao City, Cebu** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱10,717.00** worth of assistance was provided to the affected family; of which, **₱8,717.00** from **DSWD** and **₱2,000.00** from the **Local Government Unit (LGU)** (see Annex D).
