

# DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Kiwalan, Iligan City, Lanao del Norte

29 March 2024, 6PM

## I. Situation Overview

On 10 January 2024 at around 6:44 PM, a fire incident occurred at Brgy. Kiwalan, Iligan City, Lanao del Norte. The fire was declared out at around 7:04 PM.

Relative to the incident, the DSWD through its Field Office in Region X, together with the Local Government Unit (LGU) of Iligan City, provided relief augmentation to support the immediate needs of the affected families and individuals.

## II. Status of Affected Areas and Population

A total of **six (6) families** or **12 persons** were affected in **Brgy. Kiwalan, Iligan City, Lanao del Norte** (see Annex A).

## III. Status of Displaced Population

### Inside Evacuation Center

A total of **six (6) families** or **12 persons** sought temporary shelter in **Brgy. Kiwalan Gymnasium, in Iligan City, Lanao del Norte** (see Annex B).

## IV. Damaged Houses

A total of **three (3) houses** were damaged; of which, **two (2)** are **totally damaged** and **one (1)** is **partially damaged** in **Brgy. Kiwalan, Iligan City, Lanao del Norte** (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of **₱70,401.00** worth of assistance was provided to the affected families composed of **₱52,551.00** from **DSWD** and **₱17,850.00** from the **Local Government Unit (LGU)** (see Annex D).
