





DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Paknaan, Mandaue City, Cebu

28 February 2024, 6AM

I. Situation Overview

On 02 January 2024 at around 12:45 PM, a fire incident occurred at Zone Camote, Brgy. Paknaan, Mandaue City, Cebu. The fire was declared out at around 1:31 PM.

In response, the DSWD, through its Field Office in Region VII, coordinates with the concerned LGU for possible resource augmentation while continuously monitoring the situation. Consequently, the LGU of Mandaue City pledges to manage and oversee the condition of IDPs and provide interventions to the affected families and individuals as necessary. Hence, this report is terminated.

A total of **28 families** or **100 persons** were affected in **one (1) barangay** in **Zone Camote, Brgy. Paknaan, Mandaue City, Cebu** (see Annex A).

A total of **28 families** or **100 persons** currently taking temporary shelter in **Brgy. Paknaan Gym, Mandaue City, Cebu** (see Annex B).

IV. Damaged Houses

A total of 13 houses were damaged; of which, 12 are totally damaged and one (1) is partially damaged in Zone Camote, Brgy. Paknaan, Mandaue City, Cebu (see Annex C).
