



DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Poco Chico, Dagupan City, Pangasinan

11 February 2034, 6AM

I. Situation Overview

On 27 January 2024 at around 1:15 AM, a fire incident occurred in Brgy. Pogo Chico, Dagupan City, Pangasinan.

In response to the incident, the DSWD through its Field Office in Region I together with the LGU of Dagupan City, Pangasinan, provided intervention to support the immediate needs of affected families and individuals by means of relief assistance.

II. Status of Affected Areas and Population

A total of **14 families** or **51 persons** were affected in **Brgy. Pogo Chico, Dagupan City, Pangasinan** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **14 families** or **51 persons** still temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **14 houses** were damaged; of which, **7** are **totally damaged** and **7** are **partially damaged** in **Brgy. Pogo Chico, Dagupan City, Pangasinan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱100,585.50 worth of assistance was provided to the affected families; composed of ₱72,085.50 from DSWD and ₱28,500.00 from the Local Government Unit (LGU) (see Annex D).


