

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Sambag II, Cebu City

06 December 2024, 6AM

I. Situation Overview

On 26 January 2024 at around 4:50 PM, a fire incident occurred at Sitio San Juan in Brgy. Sambag II, Cebu City. The fire was declared out at around 5:12 PM.

A total of **26 families** or **94 persons** were affected in **Brgy. Sambag II, Cebu City** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

A total of **26 families** or **94 persons** sought temporary shelter at the **Mahalika Gym** in **Brgy. Sambag II, Cebu City** (see Annex B).

IV. Damaged Houses

A total of **14 houses** were **totally damaged** in **Brgy. Sambag II, Cebu City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱958,956.00** worth of assistance was provided to the affected families; of which, **₱130,000.00** from **DSWD** and **₱828,956.00** from the **Local Government Unit (LGU)** (see Annex D).
