

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Solong, Sibalom, Antique

I. Situation Overview

On 12 January 2024 at around 12:30 PM, a fire incident occurred in Brgy. Solong, Sibalom, Antique. According to the Bureau of Fire Protection (BFP), the cause of fire was allegedly due to a faulty electrical wire. The fire was declared out at around 1:43 PM.
