

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Tabu, Ilog, Negros Occidental

18 March 2024, 6AM

I. Situation Overview

On 04 January 2024 at around 3:00 PM, a fire incident occurred in Brgy. Tabu, Ilog, Negros Occidental. According to the Bureau of Fire Protection (BFP) – Ilog the fire cause was due to faulty electrical wirings and it was declared fire out at around 4:15 PM.

Relative to the incident, the DSWD through its Field Office in Region VI, together with the Local Government Unit (LGU) of Ilog, Negros Occidental, provided relief augmentation to support the immediate needs of the affected families and individuals.

One (1) family or **six (6) persons** were affected in **Brgy. Tabu, Ilog, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **six (6) persons** temporarily stayed with relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Tabu, Ilog, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱12,016.00** worth of assistance was provided to the affected family composed of **₱7,016.00** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
