





DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Tagukon, Kabankalan City, Negros Occidental

06 March 2024, 6AM

I. Situation Overview

On 07 January 2024 at around 2:30 PM, a fire incident occurred in Brgy. Tagukon, Kabankalan City, Negros Occidental. According to the Bureau of Fire Protection (BFP), the fire was allegedly caused by electrical faulty wiring. The fire was declared out at around 3:35 PM.

To support the immediate needs of the affected family, the DSWD through its Field Office in Region VI, together with the Local Government Unit (LGU) of Kabankalan, City, has provided intervention through the provision of Food and Non-Food Items (NFIs). To date, the displaced family has transferred to their newly built house in the same barangay.

II. Status of Affected Areas and Population

One (1) family or nine (9) persons were affected in Brgy. Tagukon, Kabankalan City, Negros Occidental (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **one (1) family** or **nine (9) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Tagukon, Kabankalan City, Negros Occidental (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱6,947.78 worth of assistance was provided to the affected families; composed of ₱4,447.78 from the DSWD and ₱2,500.00 from the Local Government Unit (LGU) (see Annex D).
