I. Situation Overview

On 24 January 2024 at around 4:21 PM, a fire incident occurred at Admiral Road, Brgy. Talon Tres, Las Piñas City. The fire was declared out at around 5:08 PM.

A total of **21 families** or **62 persons** were affected in **Brgy. Talon Tres, Las Piñas City** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

A total of **21 families** or **62 persons** sought temporary shelter at the **Carmencita Village Covered Court** in **Brgy. Talon Tres, Las Piñas City** (see Annex B).

IV. Damaged Houses

A total of **12 houses** were **totally damaged** in **Brgy. Talon Tres, Las Piñas City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱166,149.69.00 worth of assistance from **DSWD** was provided to the affected families (see Annex D).
