

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Tampalon, Kabankalan City, Negros Occidental

11 March 2024, 6AM

I. Situation Overview

On 16 January 2024 at around 8:10 AM, a fire incident occurred in Brgy. Tampalon, Kabankalan City, Negros Occidental. The fire was declared out at around 9:18 AM.

In response, the DSWD through its Field Office in Region VI, together with the Local Government Unit (LGU) of Kabankalan City, provided relief augmentation to support the immediate needs of the affected family.

II. Status of Affected Areas and Population

One (1) family or three (3) persons were affected in **Brgy. Tampalon, Kabankalan City, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or three (3) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Tampalon, Kabankalan City, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱6,947.78** worth of assistance was provided to the affected family composed of **₱4,447.78** from the **DSWD** and **₱2,500.00** from the **Local Government Unit (LGU)** (see Annex D).
