





DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Tan-awan, City of Kabankalan, Negros Occidental 11 March 2024, 6AM

I. Situation Overview

On 09 January 2024 at around 7:30 PM, a fire incident occurred in Brgy. Tan-awan, City of Kabankalan, Negros Occidental. The fire was declared out at around 8:35 PM.

Relative to the incident, the DSWD through its Field Office in Region VI, together with the Local Government Unit (LGU) of Kabankalan City, provided relief augmentation to support the immediate needs of the affected family.

II. Status of Affected Areas and Population

One (1) family or five (5) persons were affected in Brgy. Tan-awan, City of Kabankalan, Negros Occidental (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center
One (1) family or five (5) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Tan-awan, City of Kabankalan, Negros Occidental (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱6,947.78 worth of assistance was provided to the affected family composed of ₱4,447.78 from the DSWD and ₱2,500 from the Local Government Unit (LGU) (see Annex D).
