## **DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Tan-awan, City of Kabankalan, Negros Occidental**

11 March 2024, 6AM

### **I. Situation Overview**

On 09 January 2024 at around 7:30 PM, a fire incident occurred in Brgy. Tan-awan, City of Kabankalan, Negros Occidental. The fire was declared out at around 8:35 PM.

Relative to the incident, the DSWD through its Field Office in Region VI, together with the Local Government Unit (LGU) of Kabankalan City, provided relief augmentation to support the immediate needs of the affected family.

**One (1) family or five (5) persons** were affected in **Brgy. Tan-awan, City of Kabankalan, Negros Occidental** (see Annex A).

**One (1) family or five (5) persons** temporarily stayed with their relatives (see Annex B).

### **IV. Damaged Houses**

**One (1) house** was **totally damaged** in **Brgy. Tan-awan, City of Kabankalan, Negros Occidental** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱6,947.78** worth of assistance was provided to the affected family composed of **₱4,447.78** from the **DSWD** and **₱2,500** from the **Local Government Unit (LGU)** (see Annex D).
