On 17 January 2024 at around 3:00 PM, a fire incident occurred in Brgy. Tawagan Norte, Labangan, Zamboanga del Sur.

IV. Damaged Houses

A total of **15 houses** were **totally damaged** in **Brgy. Tawagan Norte, Labangan, Zamboanga del Sur** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱98,259.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
