

# DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Ususan, Taguig City

19 February 2024, 6AM

## I. Situation Overview

On 31 December 2023 at around 4:58 PM, a fire incident occurred at Bldg. 17 extension MRB, Brgy. Ususan, Taguig City, and was declared fire out at around 5:27 PM.

Further, four (4) residential structures were totally gutted by the incident that has led to displacement of 14 families' equivalent to 50 individuals. In response, the DSWD through its Field Office in the National Capital Region (NCR), provided relief assistance to support the immediate needs of the affected families and individuals.

A total of **four (4) houses** were **totally damaged** in **Brgy. Ususan, Taguig City** (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of **₱72,882.46** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
