

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Vilvar, San Remigio, Antique

11 March 2024, 6AM

I. Situation Overview

On 15 January 2024 at around 12:30 PM, a fire incident occurred in Brgy. Vilvar, San Remigio, Antique. The fire was declared out at around 1:43 PM.

Relative to the incident, the DSWD through its Field Office in Region VI, promptly provided relief augmentation to support the immediate needs of the affected family.
