I. Situation Overview

On 14 February 2024 at around 7:00 AM, the second floor of St. Peter Church in Brgy. Tungkong Mangga, San Jose Del Monte City, Bulacan collapsed resulting in several casualties.

DSWD FO III thru SWAD Office Bulacan immediately conducted validation and assessment on the needs of the affected individuals. The City Government of San Jose Del Monte conducted rescue operation and transported the injured individuals to the nearest hospital for appropriate medical care.
