



DSWD DROMIC Report #1 on the Fire Incident in Brgy. 310, Manila City

as of 01 February 2024, 6AM

I. Situation Overview

On 31 January 2024 at around 3:12 PM, a fire incident transpired in Brgy. 310, Manila City and was declared fire under control at 5:25 PM. Thousands of families and individuals affected by the incident are currently seeking temporary shelter in Barangay 310, Covered Court and with nearby relatives.

In response, Manila Department of Social Welfare and Disaster Risk Reduction and Management Council are actively involved in the response operation to address displacement concerns, and protection issue of displaced population and manage the aftermath of the incident.

Moreover, the DSWD through its Field Office in the National Capital Region has conducted Rapid Damage Assessment and Needs Analysis (RDANA) to evaluate the current state of displaced populations and determine immediate relief and response requirements. Currently, thorough validation and assessment is still ongoing.

II. Status of Affected Areas and Population

A total of **1,300 families** or **5,200 persons** are affected in **Brgy. 310, Manila City** (see Annex A).

III. Status of Displaced Population

a. Inside Evacuation Center

There are **80 families** or **320 persons** currently taking temporary shelter in **Brgy**. **310 Covered Court** in **Brgy**. **310**, **Manila City** (see Annex B).

b. Outside Evacuation Center

There are **1,220 families** or **4,880 persons** temporarily staying with their relatives or friends (see Annex C).

c. Total Displaced Population

There are **1,300 families** or **5,200 persons** displaced in **Brgy. 310, Manila City** (see Annex D).

IV. Damaged Houses

A total of **433 houses** were **totally damaged** in **Brgy. 310**, **Manila City** (see Annex E).
