I. Situation Overview

On 17 February 2024 at around 8:45 AM, a fire incident occurred at Purok Duranta, Kalye Putol, Brgy. Central, City of Mati, Davao Oriental. The fire was declared out at around 10:39 AM.

A total of 49 families or 170 persons are affected in Brgy. Central, City of Mati, Davao Oriental (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

There are 49 families or 170 persons currently taking temporary shelter at the Brgy. Central Evacuation Center in City of Mati, Davao Oriental (see Annex B).

IV. Damaged Houses

A total of 37 houses were damaged; of which, 30 are totally damaged and seven (7) are partially damaged in Brgy. Central, City of Mati, Davao Oriental (see Annex C).
