

## DSWD DROMIC Report #1 on the Fire Incident in Brgy. Cogon Combado, Ormoc City as of 24 February 2024, 6PM

### I. Situation Overview

On 22 February 2024 at around 7PM, a fire incident occurred in Brgy. Cogon Combado, Ormoc City.

A total of **48 families** or **240 persons** are affected in **Brgy. Cogon Combado, Ormoc City** (see Annex A).

### III. Status of Displaced Population

#### Inside Evacuation Center

There are **48 families** or **240 persons** currently taking temporary shelter in **Brgy. Cogon Combado Covered Court** in **Ormoc City** (see Annex B).

### IV. Cost of Humanitarian Assistance Provided

A total of **₱338,320.22** worth of assistance was provided by **DSWD** to the affected families (see Annex C).
