
DSWD DROMIC Report #3 on the Fire Incident in Brgy. 310, Manila City as of 08 February 2024, 6AM

I. Situation Overview

On 31 January 2024 at around 3:12 PM, a fire incident transpired in Brgy. 310, Manila City at around 3:12 PM. The fire was declared out at around 7:56 pm.

A total of **440 families** or **1,490 persons** are affected in **Brgy. 310, Manila City** (see Annex A).

III. Status of Displaced Population

a. Inside Evacuation Center

There are **80 families** or **320 persons** currently taking temporary shelter in **Brgy. 310 Covered Court** in **Brgy. 310, Manila City** (see Annex B).

b. Outside Evacuation Center

There are **360 families** or **1,170 persons** temporarily staying with their relatives or friends (see Annex C).

c. Total Displaced Population

There are **440 families** or **1,490 persons** displaced in **Brgy. 310, Manila City** (see Annex D).

IV. Damaged Houses

A total of **314 houses** were **totally damaged** in **Brgy. 310, Manila City** (see Annex E).

V. Cost of Humanitarian Assistance Provided

A total of **₱2,143,642.50** worth of assistance was provided by **DSWD** to the affected families (see Annex F).
