

DSWD DROMIC Report #3 on the Fire Incident in Brgy. Cogon, Combado, Ormoc City as of 04 April 2024, 6AM

I. Situation Overview

On 22 February 2024 at around 7PM, a fire incident occurred in Brgy. Cogon Combado, Ormoc City. The Bureau of Fire Protection (BFP) immediately responded to put out the fire.

Relative to the incident, DSWD Field Office VIII provided relief augmentation to support the immediate needs of the affected families and individuals.

A total of **48 families** or **282 persons** are affected in **Brgy. Cogon Combado, Ormoc City** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

There are **48 families** or **282 persons** currently taking temporary shelter at the **Covered Court** in **Brgy. Cogon Combado, Ormoc City** (see Annex B).

IV. Damaged Houses

A total of **43 houses** were **totally damaged** in **Brgy. Cogon Combado, Ormoc City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱818,320.22** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
