

DSWD DROMIC Report #4 on the Fire Incident in Brgy. Tingub, Mandaue City, Cebu as of 10 February 2024, 6AM

I. Situation Overview

On 03 February 2024 at around 8:05 PM, a fire broke out in Brgy. Tingub, Mandaue City, Cebu. Likewise, the fire was declared out at around 8:58 PM.

In Response, the DSWD through its Field Office in Region VII together with the LGU of Cebu City, provided relief and financial assistance to support the immediate needs of affected families and individuals.

II. Status of Affected Areas and Population

A total of **81 families** or **230 persons** are affected in **Brgy. Tingub, Mandaue City, Cebu** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

There are **81 families** or **230 persons** currently taking temporary shelter at the **Tingub Elementary School** in **Brgy. Tingub, Mandaue City, Cebu** (see Annex B).

IV. Damaged Houses

A total of **28 houses** were damaged; of which, **25** are **totally damaged** and **three (3)** are **partially damaged** in **Brgy. Tingub, Mandaue City, Cebu** (see Annex D).

V. Cost of Humanitarian Assistance Provided

A total of **₱1,524,063.80** worth of assistance was provided to the affected families; composed of **₱994,063.80** from **DSWD** and **₱530,000.00** from the **Local Government Unit (LGU)** (see Annex E).
