



# DSWD DROMIC Report #5 on the Armed Conflict in Negros Occidental

as of 28 February 2024, 6AM

## I. Situation Overview

On 21 February 2024 at around 3:00 PM, an armed conflict occured in Brgy. Pinapugasan, City of Escalante, Negros Occidental between the Philippine Army and members of the Communist Party of the Philippines – New People's Army (CPP-NPA) which resulted to the displacement of families and individuals in the area.

On the following day, the residents in Brgy. San Isidro, Toboso, Negros Occidental were also affected due to the ongoing hot pursuit of the Philippine Army.

Relative to the incident, the DSWD through its Field Office in Region VI, together with the Provincial Government of Negros Occidental, actively engaged in the response operation and promptly provided relief assistance to support the immediate needs of the affected families and individuals.

# II. Status of Affected Areas and Population

A total of **360 families** or **1,364 persons** are affected in **three (3) barangays** in **Negros Occidental** (see Annex A).

# III. Status of Displaced Population

#### **Inside Evacuation Center**

There are **53 families** or **179 persons** currently taking temporary shelter at **Pinapugasan National High School** in the **City of Escalante**, **Negros Occidental** (see Annex B).

## IV. Cost of Humanitarian Assistance Provided

A total of ₱1,313,019.00 worth of assistance was provided to the affected families; composed of ₱1,013,019.00 from the DSWD and ₱300,000.00 from the Local Government Unit (LGU) (see Annex C).
