





DSWD DROMIC Report on the Fire Incident in Brgy. 101, Tondo, Manila City

08 February 2024, 6PM

I. Situation Overview

On 28 January 2024 at around 2:41 AM, a fire incident occurred at Building 11, Katuparan St., Brgy. 101, Tondo, Manila City. The fire was declared out at around 3:28 AM.

A total of **13 families** or **52 persons** were affected in **Brgy. 101, Tondo, Manila City** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **13 families** or **52 persons** are still temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally destroyed due to fire in **Brgy. 101**, **Tondo**, **Manila City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P67,881.45** worth of assistance was provided by the **DSWD** to the affected families (see Annex D).
