



# DSWD DROMIC Report on the Fire Incident in Brgy. 15, Dolores, Eastern Samar

10 February 2024, 6PM

### I. Situation Overview

On 17 January 2024 at around 1:40PM, a fire incident occurred at Brgy. 15, Dolores, Eastern Samar. Fire out was declared at around 2:30PM on the same day.

Relative to the incident, the DSWD through its Field Office in Region VIII provided relief goods to support the immediate needs of affected families and individuals.

A total of **three (3) families** or **ten (10) persons** were affected in **Brgy. 15, Dolores, Eastern Samar** (see Annex A).

# III. Status of Displaced Population

A total of **one (1) family** or **five (5) persons** temporarily stayed with their relatives (see Annex B).

# IV. Damaged Houses

A total of **three (3) houses** were damaged; of which, **one (1)** was **totally damaged** and **two (2)** were **partially damaged** in **Brgy. 15, Dolores, Eastern Samar** (see Annex C).

# V. Cost of Humanitarian Assistance Provided

A total of **₱24,459.87** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
